C. PROPOSAL NARRATIVE

1. Overview of Services to be Provided

Odle Management Group, LLC (ODLE) is a Woman-Owned Small Business (WOSB), Minority, and Small Disadvantaged Business (SDB) and is headquartered in Scottsdale, Arizona. Corporate Program Manager is based in Oklahoma.

We have experience providing quality staff assisted services to WIA/WIOA Job Corps and Workforce customers through our Job Corps Centers, WIOA One Stop Operations and Adult, Dislocated Worker and Youth services.

Odle Management Group, LLC (ODLE) is proposing complete services for One Stop Operations, Business Services, center staffing and WIOA program staffing. We propose two (2) management positions that provide both programmatic oversight and system oversight. ODLE's One Stop Operator (OSO) model provides the firewall and separation needed for compliance with 678.625. (NPRM Part II Department of Labor Employment and Training Administration 20 CFR Parts 676, 677, and 678). The One Stop Operator has no WIOA Title I programmatic duties and does not supervise Title I program staff. OSO is responsible for the coordination and oversight of the Workforce system, developing processes and assuring appropriate delivery of services. The Operator will also be responsible for assuring all core partners are meeting core measures. The Operator provides direct supervision of the proposed Resource Specialist as part of the OSO's system duties. Other duties of the operator include assuring quality of the Workforce system services, promoting all partner services to the community, analyzing customer surveys, and crossagency training. The OSO is responsible for continuous improvement. The One Stop Operator is a half time position that also applies half of their time to Business Services.

The second management position is the Operation Manager (OM). Operations Manager is responsible for all WIOA Title I activities. OM supervises Career Managers and Fiscal Specialist and provides oversight and monitoring of the Adult, Dislocated Worker, and Youth program services. OM is responsible for WIOA performance, expenditures, customer tracking and contract performance. OM approves eligibility, training, and performs all QA for case files. The Operation Manager is responsible for training and developing staff. This position will represent WIOA services in the Little Rock area and will prepare reports for the Board.

The two managers are side-by-side on the organization chart and will work as partners in the system. Both Managers report to the Corporate Program Manager.
