- I. Important Accomplishments and Notices (*indicates more is on the LRWDB website)
 - 1. *On 1/24/22 ADWS-TANF notified the LRWDB that the final signatures were received to initiate a \$275K Pre-Apprenticeship CDL Project Grant.
 - 2. On 1/18/22 the YouthBuild LR program began its sixth cohort of Mental Toughness. An additional three participants were recruited and enrolled, making twenty-nine entered in the MIS and attending classes. Staff is coordinating with the UALR CDC and the City of Little Rock for construction site work.
 - 3. On 1/21/22 the LRWDB and Equus YouthBuild LR team submitted a \$1.1M application to the DOL for new program funds. At the same time, on 1/26/22, it gathered documents to justify a 6–9-month extension of the current program.
 - 4. *On 1/24/22 the LRWDB was emailed a draft of its required annual PY20 single financial audit presented today by BKD. This report will reestablish the normal schedule of receiving the audit which was disrupted by the COVID-19 pandemic.
 - 5. On 1/24/22 the LRWDB was notified it was not awarded a \$900K reentry grant from the DOJ-OJP-BJA 2nd Chance Act for which it had applied on 6/22/21.

I. Important Accomplishments and Notices (*indicates more is on the LRWDB website)

- 1. On 1/31/22 the LRWDB submitted the final PY20 Financial Audit Report to the Federal Clearinghouse, LRWDB members, ADWS and the CLR.
- 2. *On 2/15/22 ADWS-WIOA notified the LRWDB that it had been awarded two grants totaling \$25K for Regional Planning and Sector Partnerships.
- 3. *On 2/16/22 ADWS-WIOA notified the LRWDB that it had been awarded a High Concentration of Youth grant totaling \$67K for Out-of-School Youth.
- 4. *On 2/18/22 LRWDB and Equus staff reluctantly said farewell to Rock City Reentry Program Manager Deborah Senter. Ms. Senter did a masterful job of directing more than \$2.7M in federal grants during her four-year tenure.
- 5. On 2/27/22 the ADWS-TANF dept. notified the LRWDB of approval of a \$322K Pipeline to Employment subgrant in partnership with Our House, Inc.
- 6. On 3/7/22 the DOL sent final determination of the PY17 YouthBuild Grant stating there are policy changes needed and \$124K in questioned costs resulting from not submitting Local Match as required. LRWDB staff is working with its FPO, the CEO at the CLR and other partners to resolve within 60 days.

- I. Important Accomplishments and Notices (*indicates more is on the LRWDB website)
 - 1. On 4/28/22 Shannon Rast gave notice that she will step down as full-time LRWDB Office Manager effective 5/27/22 to pursue a career opportunity in Florida. She will continue to work part-time remotely to train her replacement Lisa Myers. Shannon worked for the LRWDB for more than 2 years. We'll miss her greatly; we have benefitted from her strong accounting and leadership skills.
 - 2. *On 4/28/22 the ADWS Monitoring and Compliance Unit announced that the PY21 Monitoring Visit is scheduled to take place virtually from 6/6-10/22.
 - 3. On 5/5/22 ADWS Monitoring & Compliance Unit issued its 2nd Response to the PY19 WIOA Monitoring Report. While 3 of the 4 program findings were resolved, there remain 13 of the 19 financial findings unresolved. LRWDB was granted a 7-day extension to respond to their answers by 5/27/22.
 - 4. On 5/12/22 the DOL-ETA Dallas Regional Office informed the LRWDB that its 8-mos POP extension request for the YouthBuild LR Program was denied. This triggered more questions and efforts are underway to hold discussions with DOL.

- 1. On 5/3/22 LRWDB Executive Director attended the ADWS Local Directors' T/A Session which featured a presentation of the PY22 federal funding allotment base upon estimated numbers. Overall, the State took a 10% cut in funds, but Little Rock fared better, projected to receive \$445,564 in Youth (>34.91%), \$324,456 in Adult (<3.98%), and \$353,343 in DW (>13.32%) over PY21.
- 2. *On 4/16/22 the LRWDB Executive Director participated as a panelist for the Arkansas United (AU) "Charla" Podcast and Facebook Live on the career services available to the Latino population in AR at workforce centers.

- I. Important Accomplishments and Notices (*indicates more is on the LRWDB website)
 - 1. On 4/28/22 Shannon Rast gave notice that she will step down as full-time LRWDB Office Manager effective 5/27/22 to pursue a career opportunity in Florida. She will work part-time remotely to train her replacement Lisa Myers.
 - 2. On 6/2/22 ADWS Monitoring & Compliance Unit issued its PY20 WIOA Monitoring Report. The request for a 30-day extension not granted, 4 program findings and 10 financial findings will require a response to ADWS by 7/5/22.
 - 3. On 6/7/22 the ADWS informed the LRWDB that USDOL had denied the joint request for waiver of the PY17 Monitoring Report's final determination of disallowed costs. Under advisement of its CEO, the LRWDB sent formal notice to ADWS on 6/16/22 that it will appeal the decision before a hearing officer.

II. Outreach, Training and Attendance

- 1. On 6/7/22 LRWDB Executive Director attended the ADWS Local Directors' T/A Session which reiterated that issuance of official allocation of the PY22 federal funding allotment has not occurred. Estimated numbers are that the State will take a 10% cut in funds, but Little Rock fared better, projected to receive \$445,564 in Youth (>34.91%), \$324,456 in Adult (<3.98%), and \$353,343 in DW (>13.32%) over PY21. On 6/21/22 the ADWS official issuance was made.
- 2. *On 6/6-24/22 the ADWS Monitoring and Compliance Unit has conducted the PY21 Monitoring Visit taking place virtually.
- 3. *On 6/16/22 the LRWDB Executive Director participated as a member of the Little Rock Job Corps Center's Community Resource Committee meeting.
- 4. *On 6/17/22 the LRWDB was notified by Talentspace, its virtual job fair software platform provider, that it was terminating its US contracts, but would extend that of the LRWDB through 8/31/2022 at no cost. Equus and LRWDB staff are structuring their next hybrid virtual/in-person \$40,000 Job Fair.
- 5. *On 6/21/22 LRWDB staff attended the ADWS Negotiated Performance Measures meeting. Due to its record of serving a higher rate of targeted populations, the PY22 performance levels for nearly every measure were two percentage points lower than the State's performance level.

 - 1. *On 6/24/22 the USDOL informed the LRWDB that it been selected to receive a \$1.99M Pathway Home 3 reentry grant to serve 200 adult offenders transition back to society. This was followed with a visit from Labor Secretary Marty Walsh on 6/29/22 to Little Rock where he made the official announcement and publicly called out the good work of the LRWDB in the area of reentry.
 - 2. *On 7/11/22 Courtney Darrow joined the Equus Workforce Solutions staff as the new program manager for the Rock City Reentry Program. She will complete the final follow-up year of the previous REO Young Adults grant, and is already busy getting partners, paperwork and logistics in place for the new PH3 grant.

- I. Important Accomplishments and Notices (*indicates more is on the LRWDB website)
 - 1. *On 8/19/22 the TANF-ADWS notified the LRWDB that it would receive a WBLP Subgrant Award in the amount of \$987,314.96 to continue its program of working with Equus and Our House to serve the homeless and near homeless. This extension will expand the program to serve participants at Union Rescue Mission, Salvation Army, PATH, and Habitat for Humanity.
 - 2. *On 8/15/22 an RFP was issued for Outreach & Communications Consultant (due 9/2/22); only one response was received. Therefore, that RFP was rebid with a new RFP for Financial Audit on 9/18/22 (due 10/14/22).
 - 3. On 9/1/22 ADWS notified the LRWDB that in the final determination of the PY17 Monitoring Report were disallowed costs of \$41,032.17. The City of Little Rock paid this amount on 9/8/22. Chair Day met with ADWS on 8/9/22 to negotiate a conflict with our appeal, but it was determined that LRWDB had not followed the proper steps of its Grievances and Appeals process and policy.
